As this is one of the grant-in aid institutions, it is obligatory to follow the rules and regulations time to time. At present the college is run as per state government higher education REGULATION, University Act 2016.

2. Organisation's wide awareness and undertakings on policies with zero tolerance:

In order to maintain justice and to avoid all forms of discriminations on the basis of caste, culture and gender are under purview of zero tolerance. To deal with all type of grievances in this regard, the college has formulated internal complaint committee and a complaint box is installed to be under control of the head of the institution.

3. Mechanism for submission of online/offline students' grievances:

The institution take care of reducing burden on students affected by some of discrepancies if any through display of policy matter and call for fearlessness to come ahead. The name and contact details of redressal officials are on the College website with email IDs.

In front of the Principal chamber open complaint box is installed with 24/7 open access with a note of confidentiality.

4. Timely redressal of the grievances through appropriate committees:

The college complaint committee is strictly informed to takes a regular follow up by setting a time period to deal with student level disputes under the chair of Head of the institution if any by counselling and taking relevant actions academically as per the situation. Moreover, the institutional binding with the RTI Act 2005 is publically displayed through its website.


Short Description of the Programme:
