DECLARATION UNDER RIGHT TO INFORMATION (RTI)

STATUTORY DECLARATION ON RTI ACT

The Right to **Information** Act, 2005 (22 of 2005) has been enacted by the Parliament and has come into force from 15 June, 2005. This Act provides for right to information for citizens to secure access to information under the control of public authorities in order to promote transparency and accountability in the working of every public authority. According to University Grants Commission all Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the meaning of a Public Authority under this Act. *The Berar General Education Society's, Shri Kisanlal Nathmal Goenka Arts and Commerce College, Karanja (Lad) is affiliated college and comes under the "Grant in Aid" category and binds to Section 4(1)(b) of RTI Act 2005 of Government of India.* The statutory declaration is displayed on the college Web-site.

Shri Kisanlal Nathmal Goenka Arts and Commerce College, Karanja (Lad) run by the "The Berar General Education Society" is offering "Co-Education" and registered under the Society Act of Government of Maharashtra. The college has a Governing Body which runs as per the rules and regulations made by the Government of Maharashtra from time to time. The

committees and cells working in the college are under the statutory bodies and comes under the Section 4(1)(b) of RTI ACT 2005. The applications under the RTI Act along with a postal order/demand draft for Rs.10/- obtained in favour of Principal, Shri. Kisanlal Nathmal Goenka Arts and Commerce College, Karanja (Lad) may be sent to the Public Information Officer (PIO) or handed over in his office. All the information about the college under section 41(1)(b) of RTI Act 2005 is available for the public and it can be obtained by any citizen of India.
